A second motion was made, this time by Wiemann and seconded by Thies, to approve final payment for the Clean Water Fund contract (FY19CWF-5) at a rate of \$200.00. A third motion was then made by Nielsen and seconded by Wiemann, moving to approve final payment for the Clean Water Fund contract (FY19CWF-6) at a rate of \$412.50.
